



# Intelligent Homicides of Six Thought Leaders: Forensic and Mathematical Analysis

**Abstract:** **Introduction:** In the last century several thought leaders died suddenly with official narratives attributing their deaths to accidents, suicides or homicides by mentally ill people. Surprisingly new information has revealed that several thought leaders were victims of “intelligent homicide” sanctioned by governments. **Objective:** To identify signature traits of “intelligent homicide”. **Method:** We studied the Wikipedia and publicly accessible official narratives of death reports of James Forrestal ,Robert F Kennedy ,Martin Luther King, John Lennon, Stanley Kubrick and Princess Diana. We also reviewed publications challenging the official narratives and found x books and x forensic articles .We searched for common traits of intelligent homicide. **Results:** Forensic and mathematical data suggests, Forrestal, Kennedy, King, Lennon, Kubrick, Princess Diana were victims of “intelligent homicide”: **Discussion:** Forrestal, Kennedy ,King ,Lennon, Princess Diana were victims of “intelligent homicide” marked by the following signature traits: A. Sudden death. B. Medical evidence incompatible with official narrative. C. Lost or falsified records or crime scene evidence. D. Sudden suspicious deaths of people who have crucial information. E. Killer or killers never faced justice. **Conclusion:** Forrestal, Kennedy, King, Lennon, Kubrick, Princess Diana were victims of “intelligent homicide”.

## HIGHLIGHTS

Forrestal, Kennedy ,King ,Lennon, Kubrick and Princess Diana were victims of intelligent homicide with signature traits of

1. Sudden death.
2. Evidence incompatible with official narrative.
3. Lost or falsified records or crime scene evidence.
4. Sudden suspicious deaths of people who have crucial information.
5. Killer or killers never faced justice.

## INTRODUCTION

In the last century several thought leaders died suddenly with official narratives attributing their deaths to accidents, suicides or homicides by mentally ill people.

New evidence revealed that James Forrestal (1,2) , Robert F Kennedy (3,4) , Martin Luther King (5,6), John Lennon (7,8), Stanley Kubrick (9,10) and, Princess Diana (11,12) were victims of homicide.

## **OBJECTIVE**

To identify signature traits of intelligent homicide based upon new evidence.

## **METHOD**

We studied the Wikipedia and publicly accessible official narratives of death reports of the six subjects. We also reviewed publications challenging the official narratives and found x books and x forensic articles. We searched for common traits of engineered homicide.

## **RESULTS**

The sudden deaths of James Forrestal, Robert Kennedy, Martin Luther King, John Lennon, Stanley Kubrick, Princess Diana seem to be associated with distinctive features.

- Forensic evidence incompatible with official narrative.
- Lost or falsified records or crime scene evidence.
- Sudden suspicious deaths of people with crucial information.
- Killer or killers never faced justice.

### **James Forrestal**

James V Forestall Secretary of the Navy and First Secretary of Defense died at Bethesda Naval Hospital on May 22, 1949. His death was initially attributed to suicide(1,2).

At approximately 1:00 AM on Sunday, 1949 May 22nd, a nurse on duty on the 7th floor of the US Naval Hospital Lieutenant Dorothy Turner heard an ominously heavy thud. She quickly sounded an alarm (1,2) . The body of James V Forestall, former Secretary of Defense, dressed in pajamas and bathrobe lay sprawled a tightly wound rope around his neck was tied in a knot. His death was initially attributed to suicide . New evidence suggested Forrestal was a victim of homicide (1,2).

### ***Synopsis***

- Forrestal's personal diaries were confiscated and returned a year later with Missing pages of diary. From July 30th-To August 10th1945 (Hiroshima and Nagasaki)(1,2).
- Knowledge of extraordinarily sensitive top secrets. Pearl Harbor was not a surprise (3). Hiroshima and Nagasaki we're not necessary to end the war (4).
- Potential target for intelligent homicide for his anti-Zionist convictions and surveillance by Israeli intelligence (2).
- No autopsy, medically unnecessary involuntary hospitalization and grossly inappropriate treatment of fatigue with Insulin shock treatment (1,2).

The odds of "Forrestal was a victim of intelligent homicide" is %99.999 (2).

1. Prior to hospitalization, Dr Menninger report: Not suicidal.

2. Inappropriate hospitalization of a person with fatigue and not a danger to himself and others.
3. Planned discharge the day of death: not suicidal.
4. No suicide note left behind.
5. Inappropriate medical treatment by insulin shock for fatigue.
6. Inappropriate medical treatment restriction of visitors by clergy.
7. Medical records do not support suicidal behavior.
8. JF Diaries do not indicate despair, depression, or suicide.
9. JF was asleep, not reading or writing right prior to his death.
10. Handwriting did not match the suicidal poem JF had allegedly written.
11. Broken glass on the carpet in his room suggested violence before death.
12. No emergency alarm following the discovery of JF's disappearance for 30 minutes.
13. Body discovered with a rope around neck consistent with homicide.
14. No autopsy done after suspicious death.
15. 1500 pages of JF diaries confiscated right before his hospitalization and returned to family a year later with missing pages.
16. Crucial pages of JF diaries coinciding with Hiroshima and Nagasaki are missing.
17. Potential target for intelligent homicide for his knowledge of top secret 2nd World War Information a potential threat to national security.(10
18. Potential target for intelligent homicide for anti-Zionist convictions and surveillance by Israeli intelligence.(2)

### **Robert F. Kennedy**

Robert F Kennedy was shot and mortally wounded in the service pantry of the Ambassador Hotel, Los Angeles on June 5th, 1968. A Palestinian immigrant Sirhan Sirhan was convicted of murder (5,6). New information challenged the integrity of the original LAPD investigation pointing out multiple inconsistencies of findings based upon new acoustic ballistic and forensic data (5,6).

### ***Synopsis***

1. There were more than one shooter.
  - Total 10 bullets fired ; RFK (three), injured (five) and wall (two) (5,6).
  - Gunshots came from two opposite directions.(5,6)
2. Sirhan was not the killer: the killer shot was fired from behind and inches close to RFK (images A,B,C).

3. Thane Eugene Cesar the killer; RFK had grabbed Cesar's bow; Cesar lied about having sold the gun and died suddenly (images ABC).
4. Dr Daniel Brown testimony: Sirhan is a MKULTRA victim (7).
5. Dr William Joseph Bryan / CIA MKULTRA mind control project died suddenly soon before he was summoned to testify before the House Select Committee on assassinations(7,8)
6. LAPD destroyed vital evidence (9).
7. The odds of "RFK was a victim of homicide" is %99.99.

### **Martin Luther King**

Martin Luther King a civil rights leader who dreamt that all inhabitants of the United States would be judged by their personal qualities and not by the color of their skin received a Nobel Peace Prize for his nonviolent campaign against racism was assassinated in 1968 (10-14).

MLK was fatally shot at 6:01 p.m., April 4, 1968, as he stood on the Lorraine motel's second-floor balcony in Memphis (10-14).

James Earl Ray was convicted of MLK's murder and later died in prison. In the last several decades new information revealed that James Earl Ray was set up as a fall guy by a conspiracy involving the FBI, the Memphis Police and various governmental agencies(10-14). On December 8th, 1999, the Memphis jury took less than an hour to find in favor of the King family to find Lloyd Jowers and various governmental agencies guilty of MLK's assassination (10-14).

### **Synopsis**

- William Sullivan (FBI) documented MLK's persecution (MLK is the most dangerous Negro in this Nation from the standpoint of communism) and was silenced (10-14).
- MLK team was infiltrated by FBI assets who helped homicide of MLK (10-14).
- Frank Strausser a Memphis policeman killed MLK (10-14).
- James Earl Ray did not kill MLK(10-14).
- William Sullivan (FBI) documented MLK's persecution (MLK is the most dangerous Negro in this Nation from the standpoint of communism) and was silenced (10).
- The odds of "MLK was a victim of homicide" is %99.99 (10).

### **John Lennon**

John Lennon was killed outside his apartment building, the Dakota, in New York City on December 8, 1980. Lennon was returning from a recording session with his wife, Yoko Ono, when Chapman fired five shots, four of which hit Lennon (15-16). Chapman remained at the scene, reading *The Catcher in the Rye*, until police arrived. David Halleran M.D: Lennon was hit by four entry bullet wounds that all entered his upper left chest above his

heart. The killer shots were not fired by Mark Chapman who stood 20 feet away behind Lennon (15-16).

The declassified John Lennon FBI files contained facsimiles of the documents, including "lengthy reports by confidential informants detailing the daily lives of anti-war activists, memos to the White House, transcripts of TV shows on which Lennon appeared. The files also revealed that Hoover proposed that Lennon be arrested by local police on drug charges(15-20).

David Halleran M.D , Barbara Kammerer, Dearthtra Sato of Roosevelt Hospital believed Lennon was hit by 4 frontal chest bullet wounds (14-15). Their observations clashed with the autopsy findings and gained more significance(15-20) ; the Roosevelt Hospital emergency room records vanished. Hence , the killer shots were not fired by Mark Chapman who stood 20 feet away behind Lennon and also raised the possibility of a cover up (15-20).

### **Synopsis**

- Chapman did not fire the killer shot. Roosevelt ER staff:

Lennon had 4 frontal entry bullet wounds on his upper left chest . Chapman stood behind Lennon(15-20).

- Chapman's calmly read "Catcher in the Rye) like a CIA MKULTRA programmed victim and had- received treatment at Castle Memorial-a CIA/ MKULTRA training place(15-20).
- CIA listed Lennon as a threat to National security ((15-20).
- Lost Data: YMCI Castle Memorial records, altered travel itinerary , Roosevelt ER records ((15-20).).
- Mathematical odds of "John Lennon was a victim of EH" is %99. 99 (15-20).

### **Stanley Kubrick**

Stanley Kubrick, a legendary movie director died in his sleep in London England on 03/07/1999. According to published reports Kubrick's death was attributed to a heart attack (20). 15 years after Kubrick's death an audio visually recorded interview of Kubrick conducted by Jeremy Bernstein a British reporter revealed Mr. Kubrick's alleged confession: "Apollo flights are my masterpiece and the greatest fraud perpetrated on humanity"(21,22).

### **Synopsis**

- Kubrick's confession is authentic :The moon hoax was my greatest achievement , Apollo 11 my masterpiece (21-31)
- No autopsy, inconsistent with medical data, died suddenly 7 days after confession in violation of secrets of national security (21)
- Kubrick's written instructions for his confession not to be released for 15 years after his death suggested he was aware of high risk (21).

- The Dutch National Museum: A moon rock presented to the Dutch Prime Minister by Neil Armstrong was made of wood and came from the earth(21) .
- The odds of “Kubrick was a victim of homicide” is %99.99 (21).

### Princess Diana

In the early hours of 31 August 1997, Diana, Princess of Wales died from injuries sustained in a car crash in the Pont de l'Alma tunnel in Paris, France. Dodi Fayed, Diana's partner, and the driver, Mercedes-Benz chauffeur Henri Paul, were both found dead inside the car. Diana's bodyguard, Trevor Rees-Jones, was the only survivor of the crash (32,333,34).

Henri Paul, deputy head of security at the Ritz, Diana and Fayed departed from the hotel's rear entrance, at around 00:20 on 31 August 1997. Trevor Rees-Jones, a member of the Fayed family's personal protection team, was in the (right) front passenger seat. (32,333,34).

At 00:23 Paul lost control of the car at the entrance to the Pont de l'Alma underpass. The car reportedly struck a white Fiat, swerved to the left of the two-lane carriageway and collided head-on with the 13th column that supported the roof. It was travelling at an estimated speed of 105 km/h (65 mph)[26] - more than twice the 50 km/h (31 mph) speed limit of the tunnel. It then spun, hit the stone wall of the tunnel backwards and finally came to a stop ((32,333,34).

Rees-Jones sustained multiple serious facial injuries and a head contusion, but was conscious.. Diana was sitting in the right rear passenger seat and was critically injured, but she was also conscious. Her ribs and arm were fractured and her right collar bone was dislocated, The first person to touch Diana was off-duty physician Frederic Mailliez reported that Diana had no visible injuries .Diana was moved to the ambulance at 01:18, left the scene at 01:41, arrived at the Pitié-Salpêtrière Hospital at 02:06 and passed away at the hospital at 04:00 am ((32,333,34).

### Synopsis

- Failure to immediately transport princess Diana to the right hospital contributed to her death (12).
- Henry Paul's reckless driving was influenced by carbon monoxide intoxication(12)
- James Andanson's ( key witness) was killed by carbon monoxide(12) .
- The odds of “ Princess Diana was a victim of homicide” is %99.99(12).

Several specific features seem to be associated with the sudden deaths of James Forrestal, Robert Kennedy, Martin Luther King, John Lennon, Stanley Kubrick, Princess Diana:

- Forensic evidence incompatible with official narrative.
- Lost or falsified records or crime scene evidence.
- Sudden suspicious deaths of people who have crucial information.

## **DISCUSSION**

Converging evidence consistent with forensic and mathematical data suggests, Forrestal, Kennedy ,King (Nobel laureate),Lennon, Princess Diana(Nobel laureate) were victims of homicides marked by signature traits of “intelligent homicide”:

1. Sudden death .
2. Medical evidence incompatible with official narrative.
3. Lost or falsified records or crime scene evidence.
4. Sudden suspicious deaths of people who have crucial information .

Surprisingly, supposedly comprehensive governmental reports of sudden deaths would reveal gross omissions and errors compromising the very integrity of official narratives.

What does differentiate IH from random sudden deaths or political assassinations by a solo killer?

Almost always a criminal is identified and prosecuted when random murders occur. As importantly there would not be any evidence of foul play or cover up in random homicides.

Worthy of emphasis is the observation that governments are neither corrupt nor incapable to solve crimes but rather a small group of individuals remain immune to prosecution and commit intelligent murders without ever facing justice.

It is astonishing that two Nobel peace laureates were victimized by grotesque “intelligent homicide “reflecting enormous harm to democracy and peace.

All the above intelligent homicides must be reinvestigated.

## **CONCLUSION**

Forrestal, Kennedy ,King ,Lennon, Kubrick, Princess Diana were victims of “intelligent homicide” and new investigations are of essence for progress.
